Region I Premier League	Substitutions may be made, with the consent of the referee, at the following times: <ul style="list-style-type: none"> • prior to a throw-in by the team in possession • prior to a goal kick, by either team • after a goal, by either team • after an injury, by either team, when the referee stops play • at half time 	Unlimited substitutions. Reentry permitted
Region I Sub Regional Leagues	Substitutions may be made, with the consent of the referee, at any stoppage of play.	Unlimited substitutions. Reentry permitted
CT Premier League	Substitutions may be made, with the consent of the referee, at any stoppage of play.	Unlimited substitutions. Reentry permitted
CT State Cup	Substitutions may be made, with the consent of the referee, at any stoppage of play.	Unlimited substitutions. Reentry permitted
CT Cup	Substitutions may be made, with the consent of the referee, at any stoppage of play.	Unlimited substitutions. Reentry permitted
